

A RESOLUTION OF THE LINCOLN COUNTY BOARD OF COMMISSIONERS, KANSAS AUTHORIZING BARNARD RURAL FIRE DISTRICT, BEVERLY RURAL FIRE DISTRICT, HUNTER RURAL FIRE DISTRICT, AND SYLVAN GROVE RURAL FIRE DISTRICT TO LEVY A PROPERTY TAX RATE EXCEEDING THE REVENUE NEUTRAL RATE;

WHEREAS, the Revenue Neutral Rate for the Rural Fire Districts was calculated by the Lincoln County Clerk as follows:

Barnard RFD 1.868 mills, Beverly RFD 2.082 mills, Hunter RFD 2.119 mills, and Sylvan Grove RFD 2.011 mills; and

WHEREAS, the budget proposed by the Governing Body of the Barnard RFD, Beverly RFD, Hunter RFD, and Sylvan Grove RFD will require the levy of a property tax rate exceeding the Revenue Neutral Rate; and

WHEREAS, the Rural Fire District Governing Body's held hearings allowing all interested taxpayers desiring to be heard an opportunity to give oral testimony;

WHEREAS, the Governing Body of the Barnard RFD, Beverly RFD, Hunter RFD, and Sylvan Grove RFD, having heard testimony, still finds it necessary to exceed the Revenue Neutral Rate.

NOW, THEREFORE, BE IT RESOLVED BY THE LINCOLN COUNTY BOARD OF COMMISSIONERS AFFIRMING ACTION FOR THE GOVERNING BODY OF THE BARNARD RURAL FIRE DISTRICT, BEVERLY RURAL FIRE DISTRICT, HUNTER RURAL FIRE DISTRICT, AND SYLVAN GROVE RURAL FIRE DISTRICT:

That the Barnard Rural Fire District shall levy a property tax rate exceeding the Revenue Neutral Rate of 1.868 mills, that the Beverly Rural Fire District shall levy a property tax rate exceeding the Revenue Neutral Rate of 2.082 mills, that the Hunter Rural Fire District shall levy a property tax rate exceeding the Revenue Neutral Rate of 2.119 mills, and that the Sylvan Grove Rural Fire District shall levy a property tax rate exceeding the Revenue Neutral Rate of 2.011 mills.

This resolution shall take effect and be in force immediately upon its adoption and shall remain in effect until future action is taken by the Governing Body.
