Throughout this year I have had troubles with the process in declaring emergency disasters for Lincoln County, my main problem is that the Lincoln County Commissioners minutes do not reflect same date and time of adoption as that which is stated on the Resolution Declaring the Emergency, which would be in direct violation of the open meetings act. This is how I would like the matter to be resolved for future disasters.

When it is determined that a disaster has affected all or portions of Lincoln County and that a Resolution must be adopted, the Emergency Manager should contact the County Clerk, who will in turn call the County Commission Chairman to request an emergency meeting. If members are unable to attend the meeting in person, the members may attend via telephone. Minutes will then be taken to reflect an Emergency Special Meeting and dates and time will reflect correctly on the Resolution presented.

~~I would also like to change the format of the Resolution, and return to the previous Resolution format, to the board allowing a Declaration to be signed by only one member of the board, this would resolve any conflict of getting signatures from all members, and normally one of you can be located to get an actual signature. Or, I do have Signature Stamps for all members and the motion could include using these as your signatures if you are unable to attend in person.~~
