

RESOLUTION 2003-23
A Resolution Setting Solid Waste Disposal Fee

WHEREAS, K.S.A. 65-3402 establishes the definition of "Solid Waste" as garbage, refuse, and other discarded materials including, but not limited to, solid, semi-solid sludges, liquid and contained gaseous waste materials resulting from industrial, commercial, agricultural and domestic activities. Solid Waste does not include hazardous waste as defined by subsection (f) of K.S.A. 65-3430, and amendments thereto, recyclables or the waste of domestic animals as described by subsection (a)(1) of K.S.A. 65-3409, and amendments thereto, and

PRUSUANT to K.S.A. 65-3410, the Board of County Commissioners of Lincoln County, Kansas, did resolve to collect solid waste disposal fees on occupied residences located within the boundaries of Lincoln County, Kansas, commencing January 1, 1993. A residential unit shall be defined as a dwelling unit such as a home, mobile home or multifamily dwelling of four or fewer units where one electric meter serves all units.

BE IT HEREBY RESOLVED, to establish the 2004 solid waste disposal fee to be charged to each occupied residence located within Lincoln County, Kansas, commencing January 1, 2004, and continuing with all years thereafter until changed by resolution or law, at \$60.00 per household. All Lincoln County, Kansas, occupied residence collected on a city utility billing in the Cities of Barnard, Beverly, Lincoln Center and Sylvan Grove shall be billed at the rate of \$5.00 per resident per month.

BE IT FURTHER RESOLVED, pursuant to K.S.A. 65-3410, to bill all other occupied residential units located within Lincoln County, Kansas, at the rate of \$60.00 per household per year, commencing January 1, 2004 and continuing with all years thereafter until changed by resolution or law, fee to be billed on the 2003 ad valorem tax year statement and mailed to the property owner to whom tax statements are mailed in accordance with K.S.A. 79-2001, and

PURSUANT TO K.S.A. 65-3410 the Board of County Commissioners of Lincoln County, Kansas, did resolve to collect solid waste disposal fees on each operating business, commercial or industrial activity located within Lincoln County, Kansas, based upon an estimate of solid waste generated or by the actual weight recorded at the Lincoln County Solid Waste Transfer Station, and


BE IT FURTHER RESOLVED, to establish a four cent per pound 2004 solid waste disposal fee commencing January 1, 2004 and continuing with all years thereafter until changed by resolution or law, to be charged to each operating business, commercial or industrial activity located within Lincoln County, Kansas, and

BE IT FURTHER RESOLVED to establish a minimum 2004 solid waste disposal fee of \$60.00 per year to be charged to each operating business, commercial or industrial activity located within Lincoln County, Kansas, commencing January 1, 2004 and continuing with all years thereafter until changed by resolution or law, and


BE IT FURTHER RESOLVED, to collect a 1 1/2% penalty on all operating businesses, commercial or industrial activity accounts not received within thirty days of billing date.
